Title:	Change provisions relating to reemployment, reinstatement, repayment, and age eligibility for
	certain members under the County Employees Retirement Act and State Employees Retirement Act

Summary:	LB 35 makes two changes. It clarifies that a state or county permanent employee must be at least 18 years old before he or she is eligible for membership in the State or County Plan. It changes reemployment rules for County and State Employees Plan members effective January 1, 2020 so that when a State or County Plan member reemploys, he or she goes back into the same defined contribution or cash balance plan into which the member was last contributing.

Title:	Change provisions relating to access to public records and provide for fees
Status:	Jan 08, 2020 - Title printed. Carryover bill
Summary:	LB 150 this bill would allow custodians of public records to charge a fee for the fulfillment of public records requests by non-residents of Nebraska. Unlike the charge for Nebraska residents, the fee for non-residents would include a charge for the existing salary for public
	employees who do the work to fulfill the request. There is an exception for News Media regardless of their state of domicile. The bill also includes a number of harmonizing changes.

Title:	Change expense reimbursement provisions for state officers and agencies
Status:	Feb 04, 2020 - Placed on Final Reading with <u>ST40</u>
Summary:	This legislative proposal seeks to modify the rate of reimbursement for any meal or incident expenses for any state officer, employee or member of any commission, council, committee, or board of the State incurred during an approved travel status to be 75%-100% of the federal General Services Administration (GSA) diems model as determined by and in accordance with policies established by the Director of Administrative Services.
	<u>AM207</u> – Language, "per diem rates of the federal General Services Administration for travel within the contiguous United States, the United States Department of Defense for travel within Alaska, Hawaii, or a United States territory or possession, and the United States Department of State for foreign travel, as determined by" added.
	<u>AM2017</u> – Clarifies that employees of the Legislature shall be compensated for actual expenses. Also clarifies that the percentage of per diem rates of the GSA also includes Alaska, Hawaii, or a United States territory or possession, and the United States Department of State for foreign travel.

Title:	Adopt the Missing Middle Housing Act and provide zoning regulation requirements for certain cities

Title:	Change provisions relating to the Occupational Board Reform Act
Status:	Feb 03, 2020 - Notice of hearing for February 13, 2020 before the Govt, Military and VA Committee
Summary:	LB1187 would require that occupational boards issue an occupational license or government certification to an individual upon application if they meet a set of reasonable criteria through their work experience of a similar scope in another state, in lieu of the personal qualification requirements present in the application for that occupational license or government certificate. LB1187 allows the occupational board to require the applicant pass a jurisprudential examination specific to relevant state law that regulates the occupation, if the occupational license or government certification requires an applicant pass a jurisprudential examination specific to relevant state statutes and administrative rules and regulations that regulate the occupation.

Notes:	Director Kohtz discussed Title XI implications with Senator La Grone's office and requested that the Board be exempt from this bill, or that the bill include an exemption for agencies that must adhere to federal requirements. Senator La Grone's office requested that Director Kohtz speak with Laura Ebke with the Platte Institute to work out a resolution. Ms. Ebke indicated that she is willing to add language "not to be in conflict with federal requirements" to section 2 of the bill.
