NRPAB Quick Hits:

- Congratulations to Ben Hynek, who was elected as the Board's chairperson for 2020, and to Chris Mustoe, who was elected as the Board's vice chairperson. Board Member Hynek has served on the Board since 2016, and was the vice chairperson in 2017 and chairperson in 2018 and 2019. 2020 will be Hynek's third stint as chairperson. Board Member Mustoe completed his first year as a board member in 2017, and also served as the Board's vice chairperson in 2018 and 2019. Both individuals have displayed the leadership qualities needed to continue the Board's momentum into 2020 and beyond.
- The Nebraska Real Property Appraiser Board retired no guidance documents, and adopted no guidance documents between October and December. All Guidance Documents are available for viewing on the Board's website at: <u>https://appraiser.ne.gov/guidance_documents.html</u>.
- LB775 was introduced by Senator Williams on January 8, 2020 to update the Nebraska Real Property Appraiser Act for compliance with Title XI of FIRREA, USPAP, and the Policy Statements of the Appraisal Subcommittee of the Federal Financial Institutions Examination Council. LB775 also includes minor changes to address administration of the Act. The hearing before the Banking, Commerce, and Insurance Committee took place on January 27, 2020. LB775 was passed to General File on an 8-0 Committee vote. The Nebraska Real Property Appraiser Board will hold a public hearing at 11:00 a.m. on Thursday, March 19, 2020 in the Nebraska Real Property Appraiser Board Office on the 1st Floor of the Nebraska State Office

Building at 301 Centennial Mall South, Lincoln, Nebraska for proposed changes to Title 298 of the Nebraska Administrative Code. Draft copies of all rules and regulations to be adopted, amended, or repealed are available for examination at the Nebraska Real Property Appraiser Board office, Monday through Friday, between 8:00 a.m. and 5:00 p.m., and on the Nebraska Secretary of State's website at https://sos.nebraska.gov/. The proposed changes to Title 298 reduce unnecessary regulatory burden and remove barriers to entry into the real property appraiser profession, include general updates for better clarification and administration, and harmonize Title 298 with the changes made to the Nebraska Real Property Appraiser Act through LB77 in 2019. The proposed changes to Title 298 will have no fiscal impact on current credential/registration holders, the public, or other political subdivisions. All interested persons are invited to attend and testify orally or by written submission at the hearing. Interested persons may also submit written comments prior to hearing, which will be made part of the hearing record at the time of hearing if received by the Nebraska Real Property Appraiser Board on or before March 18, 2020. If auxiliary aids or reasonable accommodations are needed to participate in the hearing, or if hearing impaired, please contact the Board's office at 402-471-9015 by no later than Tuesday, March 17, 2020.

Governor Pete Ricketts appointed Nebraska Certified General Real Property Appraiser Bonnie M. Downing to the Nebraska Real Property Appraiser Board as the Third Congressional District Certified Real Property Appraiser Representative on January 17, 2020. Newly appointed Board Member Downing was sworn in by Chief Deputy Secretary of State Colleen Byelick at the Board's regular meeting on February 20, 2020.

Downing graduated from Fullerton High School in 1985, and earned a Bachelor of Arts Degree in Business Management and Administration from Chadron State College in 1988. In 2010, Downing earned her Accredited Rural Appraiser (ARA) designation through the American Society of Farm Managers and Rural Appraisers.





Real Property Appraiser and AMC Numbers and Trends as of January 1, 2020

The charts below outline the five-year trend for the number of Nebraska credentialed real property appraisers and Nebraska registered appraisal management companies up to January 1, 2020. There are currently 631 licensed residential, certified residential, and certified general real property appraisers in Nebraska, and 71 credentialed trainee real property appraisers. In addition, there are currently 93 appraisal management companies registered in Nebraska.




Real Property Appraiser Renewal Report as of January 2020

The charts below outline the real property appraiser renewal counts and percentages as of January 2020. There were 487 trainee, licensed residential, certified residential, and certified general real property appraiser renewals due, and 431 credentials were renewed.



NRPAB Financial Snapshot as of December 31, 2019

For the Real Property Appraiser Program, which includes both the appraiser fund and the AMC fund, a total of \$213,532.51 in expenditures and \$236,448.14 in revenues were recorded as of December 31, 2019. Actual expenses registered at 44.14 percent of the budgeted expenditures for the fiscal year; 50.41 percent of the fiscal year has passed.
